

## **E- VISA**

**(1) e-Visa' has three sub-categories:**

(a) '**e-Tourist Visa**', (b) '**e-Business Visa**' and (c) '**e-Medical Visa**'.

(2) Applicants of the eligible countries/territories may apply online minimum 4 days in advance of the date of arrival with a window of 120 days. *Example: If you are applying on 1st Sept then applicant can select arrival date from 5th Sept to 2nd Jan.*

(3) The validity of e-Visa will be 60 days from the date of arrival in India. Double entry is permitted on e-Tourist Visa and e-Business Visa. Triple entry will be permitted on e- Medical Visa.

(4) Biometric details of the applicant will be mandatorily captured at Immigration on arrival in India.

Note:-

(a) *e-Visa can be availed for maximum of two times in a calendar year i.e. between January to December.*

(b) *e-Visa is non-extendable, non-convertible & not valid for visiting Protected/Restricted and Cantonment Areas. If you intend to visit Protected/Restricted/Cantonment areas, you would require prior permission from the Civil Authority*

### **Activities permitted under 'e-Visa':**

(a) **e-TouristVisa:** Recreation, sightseeing, casual visit to meet friends or relatives, and attending a short-term yoga programme.

(b) **e-BusinessVisa:** All activities permitted under normal Business Visa.

(c) **e-MedicalVisa:** Medical treatment, including treatment under Indian systems of medicine.

**Note:** *A foreign national will also be permitted to club these activities provided he/she had clearly indicated the same in the application form along with requisite documents.*

### **E-Visa Fee:**

E-Visa fee for Australian nationals is **US\$ 50.00**. (Note: - Bank charge of 2.5% will be charged additional on applicable e-Visa fees.)

### **Advisory:**

Services of e- Visa involves completely online application for which no facilitation is required by any intermediary / agents etc. It is advised not to believe or fall in trap of any such unscrupulous elements. For any clarification or doubt may contact
